



**EMERGENCY CEASE AND DESIST ORDER  
FOR UNPERMITTED ACTIVITY  
UNDER SECTION 11-4-025 OF THE MUNICIPAL CODE OF CHICAGO**

PLEASE BE ADVISED that the Commissioner of Public Health has found that you are operating a facility or conducting an activity without a required permit or other written authorization issued by the Commissioner, in that you have been found to be operating a scrap metal recycling facility at the above-stated location without a recycling facility permit issued by the Department of Public Health.

AS OF THIS DATE, JUNE 07, 2012, YOU ARE HEREBY ORDERED TO CEASE AND DESIST from collecting, storing, or processing recyclable material, or otherwise operating a recycling facility, without a recycling facility permit.

PLEASE BE FURTHER ADVISED that you are in violation of the following sections of the Municipal Code of Chicago: 1) section 11-4-2520, in that you have engaged in the business of operating a recycling facility in the City of Chicago without having first obtained a written recycling facility permit from the commissioner; 2) section 7-28-720, in that you permitted the accumulation of materials or junk; 3) section 11-4-2580 in that you failed to segregate and store recyclable materials in approved receptacles or enclosures; 4) section 11-4-2590, in that you failed to clearly and properly mark receptacles for the storage of recyclable materials; 5) section 11-4-2600, in that you failed to maintain storage areas in a clean and sanitary manner; and 6) section 7-28-080, in that you permitted a nuisance to exist in connection with a business.

**IMPORTANT INFORMATION**

You shall have 14 calendar days from the service date of this Order to notify the Commissioner, on the form attached hereto, of your demand for a hearing. At the hearing you may contest any of the allegations specified in this Order or you may present evidence as to why you are not liable for all or any of the violations specified in this Order, and/or why the Order should be vacated. Failure to notify the Commissioner of a demand for a hearing in the time and manner described above shall constitute a waiver of the opportunity for a hearing. Submittal of a demand for hearing shall not relieve you of the duty to comply with this Order.

Failure to comply with this Order is a violation of section 11-4-025 of the Code and will subject you to a penalty of \$5,000 per day, in addition to any other applicable penalties or costs.
