A Message from Attorney General Lisa Madigan

With the holiday season just around the corner, gift shopping has begun in earnest. Every year at this time, I encourage parents, grandparents, caregivers and anyone buying gifts for children to take a moment to review our annual *Safe Shopping Guide* that details dangerous children's toys and products that were recalled in 2016.

I have issued this guide every year since 2007, when a startling 44 million units of children's products were recalled, to help Illinois families keep up with the many products that are recalled every year. This year's guide details 84 recalls issued by the U.S. Consumer Product Safety Commission since January, including descriptions and photographs of toys, cribs and furniture, children's clothing and other children's products.

This year, families need to watch out for 10 recalls of self-balancing scooters or hoverboards with defects that can cause the products to catch fire or explode. Other recalls included toys and children's jewelry with excessive levels of lead, baby rattles that can break and cause a choking hazard for infants and several different strollers with defects that can cause injuries.

I urge you to read through this guide as you begin your holiday shopping. You may also want to print a copy and take it with you as you shop to make sure you do not bring home a recalled item. Please keep in mind that you may see recalled items for sale in locations other than retail stores. Recalled items may also be available at yard and garage sales and secondhand websites such as Craigslist and eBay. In reviewing our guide, you may even realize that you already have a recalled item in your own home.

It's important to take time to ensure that you do not have dangerous recalled products in your home and take appropriate precautions when purchasing new toys and products for children so you can help your family and friends have a safe holiday season and new year.

Recalls from January 1, 2016 through November 16, 2016

Target Recalled Halloween LED Gel Clings Due to Choking and Button Battery Ingestion Hazards on October 20, 2016

The gel clings can separate and expose the inner decal and LED/button battery compartment, posing choking and button battery ingestion hazards to children. Sold exclusively at Target stores nationwide from August 2016 through September 2016. Consumers should immediately remove the recalled gel clings from areas with children and return them to any Target store for a full refund.

Roylco Recalled Educational Light Cubes Due to Fire Hazard on October 13, 2016

The light cube's lithium polymer battery can overheat and catch fire, posing a fire hazard. Sold at educational dealers and distributors nationwide, including Beyond Play, Charles J. Becker, Excelligence, Hatch and Kaplan from December 2013 through April 2016. Consumers should immediately stop using the recalled light cubes and contact Roylco for instructions on returning the light cubes for a free replacement of the light source, which contains the battery.

Sargent Art Recalled Craft Paints Due to Risk of Exposure to Bacteria on October 4, 2016

The paint can contain harmful bacteria. Exposure to certain bacteria can have adverse health effects in immunocompromised individuals, posing a risk of serious illness including bacterial infection. Consumers with healthy immune systems are not generally affected by the bacteria. Sold at Hobby Lobby, Walmart and other stores nationwide and online at amazon.com and shopsargentart.com from May 2015 to June 2016. Consumers should immediately stop using the recalled paints and contact Sargent Art for a full refund.

Dazzling Toys Recalled Chicken Toys Due to Choking Hazard on August 30, 2016

The toys contain small eggs and the chicken can break into small plastic pieces, posing a choking hazard to children. Sold online at amazon.com and ebay.com from February 2016 through July 2016. Consumers should immediately stop using the recalled toys and contact the firm for a full refund. Dazzling Toys is contacting consumers who purchased the recalled toys.

McDonald's Recalled "Step-iT" Activity Wristbands Due to Risk of Skin Irritation or Burns on August 23, 2016

The recalled wristbands can cause skin irritation or burns to children. Distributed exclusively by McDonald's restaurants nationwide from August 9, 2016, to August 17, 2016, with Happy Meals and Mighty Kids Meals. Consumers should immediately take the recalled wristbands from children and return them to any McDonald's for a free replacement toy and either a yogurt tube or bag of apple slices.

Alex Toys Recalled Infant Building Play Sets Due to Choking Hazard on August 23, 2016

Small parts of the plastic toy building sets can detach, posing a choking hazard to young children. Sold at Barnes & Noble and Land of Nod and online at zulily.com. The Baby Builders were sold from December 2009 through June 2016, First Pops from March 2009 through June 2016 and First Snaps from March 2009 through October 2010. Consumers should immediately take the recalled building sets away from children and contact ALEX for a prepaid shipping envelope to return the product(s). ALEX will send consumers a full refund upon receipt of returned sets.

The USB charging cords sold with the toy can overheat, posing fire and burn hazards to consumers. Sold at Walmart and other mass merchandisers and independent toy stores nationwide and online at amazon.com from January 2015 through January 2016. Consumers should immediately stop using the USB cords and contact the firm for instructions on obtaining a free replacement charge cord.

LaRose Industries Recalled Cra-Z-Jewelz Ultimate Gem Jewelry Machine Due to Violation of Lead Standard on June 2, 2016

The “Slider Bracelet” in the jewelry making kit contains high levels of lead. Lead is toxic if ingested by young children and can cause adverse health issues. Kmart, Toys ‘R’ Us, Walmart and other retailers sold the Shimmer N’ Sparkle Cra-Z-Art Cra-Z-Jewelz Gem Creations Ultimate Gem Machine from August 2015 through April 2016. Toys ‘R’ Us, Walmart and other retailers sold the Shimmer N’ Sparkle Cra-Z-Art Cra-Z-Jewelz Gem Creations Gem Charm and Slider Bracelets from August 2015 through April 2016. Target stores sold the My Look Cra-Z-Art Cra-Z-Jewelz Gem Creations Ultimate Gem Machine from August 2015 through April 2016. Consumers should immediately take these recalled products away from children and contact LaRose for instructions to receive a full refund.

Hobby Lobby Recalled Infant Rattles Due to Choking Hazard on May 12, 2016

The rattle seams can separate, exposing the fiber stuffing and bell rattle, posing a choking hazard. Sold exclusively at Hobby Lobby Stores nationwide from January 2016 through April 2016. Consumers should immediately stop using the recalled rattles and return them to the nearest Hobby Lobby store for a full refund or store credit.

Flying Tiger Copenhagen Recalled Wooden Toys Due to Choking Hazard on April 19, 2016

Parts of the wooden toys can become detached, resulting in small pieces that can pose a choking hazard to young children. Sold exclusively at Flying Tiger Copenhagen in New York from November 2015 through December 2015. Consumers should immediately take the recalled toys from young children and return the products to Flying Tiger Copenhagen for a full refund.

The red button on the Moogy plush toy’s left pocket and the snap button on the right pocket can detach, posing a choking hazard to young children. Sold at specialty toy stores nationwide and online at amazon.com, gilt.com, highlightsforchildren.com, toysrus.com and zulily.com from July 2015 through February 2016. Consumers should immediately take the recalled toy away from children and contact Miniland Educational for instructions on destroying and disposing of the Moogy in order to receive a full refund.

Rainbow Play Systems Reannounced Recall of Plastic Yellow Trapeze Rings Due to Low Response Rate on April 7, 2016

The rings can unexpectedly crack or break during use, posing a fall hazard to children. Sold at Rainbow dealers nationwide from January 2007 through December 2011 and at several mass merchandisers including Sam’s Club, Toys ‘R’ Us and Walmart from January 2009 through December 2009. Consumers should immediately stop children from using the recalled rings, contact Rainbow for ring removal instructions, remove the rings from the play set and receive a \$10 gift card.

Manhattan Toy Recalled Table Top Toys Due to Choking Hazard on March 31, 2016

The round plastic beads can break, posing a choking hazard. Sold at BuyBuy Baby and other toy stores nationwide, and online at amazon.com and kohls.com from September 2015 through January 2016. Consumers should immediately stop using the recalled toy and return it to the store where it was purchased or contact Manhattan Toy for a full refund.

The pink metal note bar on the glockenspiel may contain excessive levels of lead in the paint, violating the federal lead paint standard. If the paint is scraped off and ingested, lead can cause adverse health effects. Sold at independent toy and music retailers and online at amazon.com and gogreentones.com from January 2015 through September 2015. Consumers should immediately remove the pink bar from the glockenspiel and contact KHS America for information on getting a free replacement pink bar.

The ball bearings inside each side of the decorative rattle can be released, posing a choking hazard to young children. Sold at Bloomingdales, Macy's and WWRD Outlets and other department stores nationwide and online at amazon.com and wedgwood.com from April 2015 through December 2015. Consumers should immediately stop using the decorative rattles, take them away from young children and contact WWRD for a full refund.

The night lights can short circuit, posing shock and fire hazard to consumers. Sold exclusively at LTD Commodities and The Lakeside Collection catalogs and online at ltdcommodities.com and lakeside.com from July 2016 through October 2016. Consumers should immediately stop using the recalled projection night lights and contact the firm for instructions to receive a full refund including shipping. All known purchasers were notified directly about the recall.

Fiddle Diddles Recalled Car Seat Strap Systems Due to Choking Hazard on October 25, 2016

The carabiners attached to the strap system contain small internal parts that can become dislodged, posing a choking hazard to young children. The carriers' side strap can loosen unexpectedly from the buckle, posing a fall hazard to the child in the carrier. A loose latch on the stroller can cause the seat to tip back unexpectedly when the infant is in the parent-facing position, posing a fall hazard to infants. Consumers should immediately stop using the strollers and contact Mamas & Papas for a free repair.

Fabric slings on the recalled infant bath tubs can detach from the tub, posing a risk of impact injury and drowning. Sold at Toys 'R' Us/Babies 'R' Us and other juvenile product specialty stores nationwide from October 2012 through October 2013. Consumers should immediately stop using the fabric sling in the recalled product and contact Summer Infant for a replacement fabric sling with a white plastic attachment clip.

Consumers should immediately take the recalled pacifier clips from babies and return the product to Babies 'R' Us or Toys 'R' Us for a refund.

The stroller tray folding mechanism can partially disengage on one side when used with an infant car seat attached to the stroller, posing a fall hazard. Sold at Babies 'R' Us and other retailers nationwide and online at amazon.com, babiesrus.com and walmart.com from May 2015 through June 2016. Consumers should immediately stop using the recalled strollers with the infant car seat and contact Safety 1st for a free repair kit.

The recalled chests are unstable unless they are properly anchored to the wall, posing a serious tip-over and entrapment hazard that could result in death or serious injury to children. Sold exclusively online at walmart.com from April 2016 through June 2016. Consumers should immediately stop using any recalled chests that are not properly anchored to the wall and place them in an area that children cannot access. Sauder Woodworking is contacting all known purchasers directly and sending free repair kits and wall anchoring kits. If a consumer is unable or unwilling to attach the repair kit, they should contact Sauder Woodworking for a full refund. Consumers who request a refund will be provided instructions by Sauder on how to properly dispose of the chests.

Consumers should immediately stop using the recalled monitors and contact Lorex to receive a full refund.








Laceration Injuries to Children Prompt Starbucks to Recall Stainless Steel Beverage Straws on August 2, 2016


