#### Proposed Protocols

The City Council acknowledges that the Black Caucus and Latino Caucus represent populations that are protected by the Voting Rights Act and that in some neighborhoods of the City, these protected populations live side-by-side in their communities. The Council further acknowledges that although the intermingling of such populations in communities of interest is a strength of these communities, the intermingling presents unique challenges for ward remapping. Accordingly, the Rules Committee shall prioritize mapping for members of the Black Caucus and Latino Caucus where their populations are intermingled and shall prioritize mapping of such areas over the mapping of areas of the City populated by non-protected groups.

Members of the Black Caucus and the Latino Caucus shall agree on suggested protocols for work in the map room. The Rules Committee shall agree to follow such protocols when mapping all wards that may be affected by adjustments to maps of members of the Black Caucus and Latino Caucus.

A subgroup of the City Council consisting of a small group of members of the Black Caucus and the Latino Caucus shall meet one time per week to review the progress of City mapping and to discuss outstanding issues and potential means to resolve those issues.

Alderpersons shall map in groups by region. A region shall consist of no less than 5 alderpersons who have wards generally located within the same geographic area of the City.

During each mapping session, alderpersons shall be shown an entire map of the City and shall be shown how the map of their region intersects with the remainder of the City. Alderpersons shall be entitled to secure statistics on how their mapping choices will affect surrounding wards. Notwithstanding mapping by region, boundaries of alderpersons in adjacent regions shall be shown to the aldermen who are present in the map room and working on mapping.

Alderspersons may be represented by counsel and by a map maker in mapping meetings, but such representatives shall not speak in the meeting except as necessary to answer questions. Otherwise, all advocacy conversations shall be held outside of the map room. Groups of alderspersons, members of Caucuses, and the Rules Committee may include counsel in their mapping meetings by region, but counsel shall be available only to respond to questions and should not interject opinions into the meeting. Counsel may ask clients to step out into the hallway to hold discussions in private.

The Rules Committee shall encourage all alderspersons to be flexible and to be willing to move boundaries in the interest of compromise. None of the wards shall be deemed to be "locked-in" in their entirety.

At the end of each mapping session conducted in a group by region, every attendee shall receive a printed copy of the regional map illustrating the agreed-upon boundaries settled in the mapping session.

Boundaries that have been agreed between members by region shall not be changed by the Rules Committee without the specific agreement of the alderspersons whose boundaries are at issue.
